**DEMO TRADING TOURNAMENT**

**CREATED 5<sup>th</sup> AUGUST 2025**

## 1. General

- a. The GTC Demo Trading Competition (“the Competition”) is organised by GTC and is open to eligible individuals as per the criteria below.
- b. Participation is completely free and no deposits are required to join.
- c. By registering, all participants agree to comply with these Terms & Conditions.
- d. The Competition is not available in jurisdictions where such promotions are restricted or prohibited.
- e. GTC reserves the right to change, suspend, or cancel the Competition and/or these Terms at its sole discretion.

## 2. Eligibility

- a. Open to individuals aged 18 years and above.
- b. Contestants must register with valid personal details, including full name, email address, phone number, and country of residence.
- c. Only one (1) registration per person is permitted. Multiple registrations will result in disqualification.
- d. Each participant will receive:
  - i. A \$10,000 MT5 demo trading account.
  - ii. Login credentials.
  - iii. A unique participant ID.
- e. Registrations must be completed via the official landing page during the sign-up window.
- f. Existing GTC clients are not eligible to participate.




### 3. Competition Format

- a. Registration
  - i. Starts on **Monday, 11<sup>th</sup> August 00:00 UAE time.**
  - ii. Ends on **Sunday, 24<sup>th</sup> August 23:59 UAE time.**
- b. Competition
  - i. Starts on **Monday, 25<sup>th</sup> August 00:00 UAE time.**
  - ii. Ends on **Thursday, 11<sup>th</sup> September 23:59 UAE time.**
- c. Participants trade on MT5 demo accounts with:
  - i. \$10,000 virtual balance.
  - ii. 1:500 leverage.
  - iii. Access to FX, metals, and commodities.
- d. Minimum of 10 trades required to qualify for prizes.
- e. The account type provided mirrors the conditions of GTC's Standard trading account.

### 4. Leaderboard & Scoring

- a. Rankings are based on percentage return (account growth).
- b. The leaderboard will be updated daily and displayed publicly on the competition page.
- c. Participants with over 60% drawdown will be disqualified.
- d. GTC reserves the right to audit and verify all account activity before announcing winners.

## 5.Prizes

Rank	Prize
 <b>1<sup>st</sup> Place</b>	\$3,000 added to a GTC Live Trading Account + Trophy.
 <b>2<sup>nd</sup> Place</b>	\$1,500 added to a GTC Live Trading Account.
 <b>3<sup>rd</sup> Place</b>	\$500 added to a GTC Live Trading Account.
<b>4<sup>th</sup> - 10<sup>th</sup> Place</b>	Win a \$200 Credit Bonus, which requires a deposit.
<b>11<sup>th</sup> - ∞</b>	All other verified participants receive a 15% Deposit Bonus on their first GTC Live Trading Account deposit.  All participants also receive a certificate.

- a. All prizes are subject to KYC verification.
- b. Prizes are non-transferable and may be substituted with equal-value alternatives at GTC's discretion.
- c. A Certificate of Participation is available upon request.

## 6.Disqualification

- a. Use of multiple registrations, shared IPs, or identical VPS setups will result in removal from the competition.
- b. Any attempt to manipulate results, including price feed abuse or exploiting platform glitches, will lead to permanent disqualification.
- c. Participants using proxy servers, VPNs, or false identity will be disqualified without notice.
- d. GTC reserves the right to remove any participant found in breach of these Terms or acting in bad faith.

## **7. Rules & Restrictions**

- a. To ensure fair competition:
  - i. Expert Advisors (EAs), copy trading, arbitrage, latency trading, and account mirroring are strictly prohibited.
  - ii. Hedging between multiple contest accounts or with other participants is not allowed.
  - iii. Any use of false identity, proxies, or VPNs to register multiple accounts will result in immediate disqualification.
  - iv. Contest accounts must not be manipulated by exploiting platform glitches, price feed abuse, or non-market behaviours.

## **8. Verification**

- a. Winners must submit government-issued ID and proof of residence to claim prizes.
- b. GTC reserves the right to request additional documentation and reject prize claims if fraudulent behaviour is suspected.

## **9. Data Use**

- a. By registering, participants consent to receiving marketing communications from GTC.
- b. All personal data will be handled in accordance with GTC's Privacy Policy.

## **10. Amendments & Disqualification**

- a. GTC reserves the right to amend, suspend, or terminate the contest at any time, without prior notice.
- b. GTC reserves the right to disqualify any participant who violates the rules or behaves unethically.

## 11. Disclaimer

- a. This is a **demo trading competition**. No real capital is at risk during participation.
- b. Joining the contest **does not constitute a solicitation** to trade or invest real funds.
